- Riverside, CA: Retailers are charged the initial fees for cart retrieval after 3 days of impoundment and then after 3 violations in a 6-month period shall be subject to a fine of \$50 per cart. <u>Link to full code</u>
- South Jordan, UT: Shopping carts found on public property may be impounded or removed entirely. <u>Link to full code</u>
